REGULAR MEETING APRIL 11, 2022



The Regular Meeting of the Town Board of the Town of New Bremen, County of Lewis and the State of New York was held at the Town Municipal Office Building, 8420 State Rte. 812, New Bremen, New York on the 11th day of April 2022.

Supervisor Keys called the meeting to order at 6:33 p.m. with the Pledge to the Flag.

RESOLUTION NO. 39 OF 2022 APPROVAL OF MINUTES

On a motion of Councilman Aucter, seconded by Councilwoman Buell, the following resolution was ADOPTED Ayes 4 Aucter, Buell, Lyndaker, Keys Nays 0

RESOLVED, the minutes of the March 14, 2022 meeting are approved.

FLOOR

Alexia Lamb of Joule Community Power gave a presentation on the company's clean energy program called CCA Community Choice Aggregation and the benefits of renewable energy to communities, such as 10% discount on delivery charges on one's electric bill. The program is a policy enabling municipalities to determine default energy offerings, including renewable electricity and community solar, on behalf of residents and small businesses. Each resident would have the "option" to "opt" out of the program if they wish. To move forward, the Town Board would need to adopt a local law which allows the company to look further at a program that would benefit the town and its residents. Discussion followed with the Board having mixed feelings about the program. Councilman Aucter doesn't feel it is their position to make household choices for our residents. Needs further review, no action at this time. Ms. Lamb thanked the board and left the meeting at 7:18 p.m.

COUNCIL REPORTS

Councilwoman Buell reported on the following:

- 1. Pratt Northam Grant received grant funds and gave to Supervisor for deposit. Placed the order for the equipment and should receive sometime in June.
- 2. Real Property Tax Law 575-B State adopted the law which specifies how solar and wind projects are to be valued in the future. Attorney Burrows sent a letter concerning the new law and how it may affect future solar projects within the town. The state is looking at revisiting the law.

Councilwoman Lyndaker reported on the following:

1. Drafted the letter of support to Trout Unlimited for submission with the full application, due by April 18th, for the culvert replacement on Brewery Road.

HIGHWAY

Highway Superintendent Herzig reported on the following, with resolution to follow:

- 1. New Pickup arrived at Nortz & Virkler's. Will go inspect it before taking delivery. Discussed advertising the 2019 pickup for bid for sale.
- 2. Fuel Shed AV Builders, Paul Campeau is not interested in building the fuel shed, therefore we have no contractor and need to figure out what the next step is. If we file for an extension, it must be done by June 1st. Discussed going with double wall fuel tanks, as it's not required to have a roof over them 1000 gal. for diesel and 500 gal. for gas. Mr. Herzig is to check on state contracts and/or obtain quotes for new tanks.
- 3. Gradeall is having issue and needs work. Dave Redman is coming to determine what is wrong with it and go from there.
- 4. Started Sweeping.
- 5. Culverts replaced two (2) that were undermined on Artz and Steiner Roads.
- 6. Tractor should be delivered to Cazenovia Equipment by June, but will not have tires as they are having issues getting them.
