Supervisor Keys called the meeting to order at 6:30 p.m. with the Pledge to the Flag with invocation.

RESOLUTION NO. 38 OF 2024 APPROVAL OF MINUTES

DOG CONTROL

DCO Astafan briefed on the following items:

- Training November 5-7th in Guilderland, NY. Town of Lowville approved already and he is looking for permission from New Bremen. Cost will be split between the two (2) towns.
- Been a couple recent instances with stray dogs and the need to capture by use of a live trap. His liability insurance will not cover the use of live traps. Lewis Co. Humane Society and another local organization are able to use live traps. The town can direct people to contact them if further instances like this occur.

PRIVILEGE OF FLOOR

Supervisor Keys opened the floor for public comment. Kenny Zehr would like permission to run 4200' of electrical line from the Soft Maple Road up the Frank Kirch Road (seasonal road) to his residence in the Town of Croghan. The line

would be placed 3' down along the side of the road within the towns right of way. Mr. Zehr is contracting with Spencer O'Brien to complete the installation. Attorney Farley does not recommend it as it could be a liability issue for the town at a later time. After further discussion it was decided to contact UDig NY for more information along with Attorney Farley concerning the liability issue. Mr. O'Brien stated he will also contact UDig NY. Mr. Zehr and Mr. O'Brien left the meeting at 6:50 p.m.

BRAC-1

Bill Mueller, our local representative on the Beaver River Advisory Council (BRAC-1). Their organization has \$100,000 in available funding for projects along or near the Beaver River. It was suggested he contact the Beaver River Recreation Association as they may have a need or use for such funds. The board thanked Mr. Mueller for his time and efforts. He left the meeting at 7:03 p.m.

COUNCIL REPORTS

Councilwoman Lyndaker reported on the following:

Clean Energy Program – submitted fleet information to fulfill the required points needed to receive the \$10,000 grant funding. It appears the funds could be used to replace the old boiler with a new, more energy efficient boiler system.

Councilman Aucter

- Community Day discussed having an open house for the community to walk through our municipal buildings, view equipment and see the operations of the town.
- Lowville Summer Youth Rec attended a meeting. They are looking for funding.

Councilman Schantz

- National Grid – transmission line upgrade? Legislator Lyndaker stated NG cancelled recent meetings with the county. Nothing new at this time.

- Updated town website with planning and ZBA members along with minutes for ZBA.
- Sent copy of the Justice Court audit report to Unified Court System per their request.

HIGHWAY

Highway Superintendent Herzig reported on the following:

- New Tandem is in Syracuse. Need to finalize the paperwork for financing. The thirty-day (30) period for transfer of funds from the equipment reserve ends the 11th of April, which was subject to permissive referendum. No petition filed yet.
- Tandem Quote reviewed the updated quote from Allegiance Trucks for a new HX520 6x4 Chassis (18 speed) with Viking Plow Package, via state contract for \$244,665.00. Will not be built until 2025 and more than likely take delivery in 2026. After discussion a resolution was presented and follows this section.
- Quote board reviewed quote from BearCom for a new repeater which includes installation and tuning of base repeater \$13,519.11. An RFP is required per towns procurement policy. Mr. Herzig will write it up.
- Part-time Laborer discussed hiring another part-time laborer for the summer on a call in basis. The board agreed as long as we stay within budget.
- Brewery Road Culvert Replacement all paperwork is complete.
