REGULAR MEETING August 10, 2020

Supervisor Keys called the meeting to order at 6:30 p.m. with the Pledge to the Flag.

RESOLUTION NO. 82 OF 2020 APPROVAL OF MINUTES

RESOLVED, the minutes of the July 13, 2020 meeting are approved.

SOLAR LAW

Board reviewed the updated "proposed" Local Law No. 1 of 2020 – Regulation of Solar Energy Systems in the Town of New Bremen. Due to changes in the first draft of the solar energy law, Attorney Farley stated the Board will need to hold another public hearing. After review and discussion, the following resolution was presented.

RESOLUTION NO. 83 OF 2020 PUBLIC HEARING SET FOR "PROPOSED" LOCAL LAW NO. 1 OF 2020

On a motion of Councilwoman Lyndaker, seconded by Councilman Becker, the following resolution was ADOPTED Ayes 4 Becker, Aucter, Lyndaker, Keys Recusal 1 Buell Nays 0

RESOLVED, that a Public Hearing will be held by the Town Board of the Town of New Bremen on September 14, 2020, at 6:30 p.m. located at 8420 State Route 812, Lowville, New York 13367 to consider the adoption of "proposed" Local Law No. 1 of 2020 - Regulation of Solar Energy Systems in the Town of New Bremen and it may be known as the "Solar Energy System Law of the Town of New Bremen".

COUNCIL REPORTS

Councilman Becker – reported an issue with excessive goose droppings on the beach which makes it difficult for people to enjoy it. Discussed the possibility of obtaining funding through the Beaver River Water Shed project. Councilwoman Lyndaker offered to contact the DEC for more information. Also, discussed the Highway crew removing the old shed that's on the beach as people are leaving garbage in there.

Councilwoman Buell – The Chamber of Commerce is looking at hosting a polar plunge on the Crystal Pond in New Bremen this winter.

Councilwoman Lyndaker – Would like to discuss some issues concerning the operations of the New Bremen Rural Cemetery. Records for the cemetery are limited and maps are worse, which makes it very difficult to locate available burial plots. Clerk Jones asked the Board about finding someone to help with plot locations and mapping of the cemetery would be very helpful. Or consider not selling plots anymore. Supervisor Keys will contact a Mr. Kuhl pertaining to mapping and website as he is working on several cemeteries in the Town of Croghan.



RETENTION AND DISPOSITION SCHEDULE

NYS Archives has revised and consolidated its local government records retention disposition schedules and is issuing a single, comprehensive retention schedule for all types of local governments on August 1, 2020. The new schedule LGS-1 or Retention and Disposition Schedule for New York Local Government Records supersedes and replaces all other schedules – CO-2, MU-1, MI-1 and ED-1. All local governments must adopt LGS-1 prior to utilizing it and must by January 1, 2021. The schedule is available for download. After discussion, the following resolution was presented.

RESOLUTION NO. 84 OF 2020 ADOPTION OF THE RETENTION AND DISPOSITION SCHEDULE FOR NEW YORK LOCAL GOVERNMENT RECORDS (LGS-1)

On a motion of Councilman Aucter, seconded by Councilwoman Lyndaker, the following resolution was ADOPTED Ayes 5 Becker, Aucter, Buell, Lyndaker, Keys Nays 0

RESOLVED, by the Town Board of the Town of New Bremen that Retention and Disposition Schedule for New York Local Government Records (LGS-1), is pursuant to Article 57-A of the Arts and Cultural Affairs Law, and containing legal minimum retention periods for local government records, is hereby adopted for use by all officers in legally disposing of valueless records listed therein.

FURTHER RESOLVED, that in accordance with Article 57-A:

- a. Only those records will be disposed of that are described in Retention and Disposition Schedule for New York Local Government Records (LGS-1), after they have met the minimum retention periods described therein;
- b. Only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods.

- 3. Summer youth worker, Cole Bennett has been approved to work 40 hrs. a week.

- 6. Changing 4 culverts, couple driveway pipes and tearing up a section of the Soft Maple Rd. for repair.
- 7. Several barrels and lights have been stolen from the roadside. Notified the local authorities and will keep a look out. Value of items stolen approximately \$1200 to \$1500.
