SITE PLAN REVIEW APP

At the December 8, 2023 meeting, the board reviewed SPRZPA No. 1-2023 submitted by Jordan Brandt for the expansion of Red Barn Meats. After review they determined additional information was required: update part 1. Section 3. on the short SEQR form with the correct acreage along with a detailed drawing of the proposed construction layout with existing buildings, well, etc. Mr. Brandt submitted all documents. After further review and discussion, the following resolution was presented.

WHEREAS, the Town Board of the Town of New Bremen reviewed Site Plan Review and Zoning Permit Application No. 1-2023, submitted by Jordan Brandt, for the proposed expansion of Red Barn Meats and construction of an approximately 4800 sq. ft. building on property located at 9095 and 9097 Briot Rd., Town of New Bremen, NY, Tax Map No. 147.00-01-18.100 and 147.00-01-18.210 (owner Jordan Brandt), now therefore be it

RESOLVED, the Town of New Bremen accepts said application and designation as Lead Agency for said project and hereby refers SPRZPA No. 1-2023 with all documentation to the Lewis County Planning Board for their review and recommendations, and be it further

RESOLVED, the Town Board of the Town of New Bremen will hold a public hearing on February 12, 2024 at 6:30 p.m. at the Town Municipal Office Building to hear all interested parties for or against said application.

ZONING LAW

At the December 8, 2023 meeting, the board reviewed the Lewis County Planning Boards approval, with modifications, for the towns proposed Local Law No. 1 of 2023 entitled "Repealing Local Law No. 2 of 2021 – Solar Energy System Law and Local Law No. 1 of 2001 – Site Plan Review Zoning Law and replacing it with Local Law No. 1 of 2023, to be known as "The Town of New Bremen Zoning Law". Adoption was deferred at that time until a full board was present. The following resolution was presented.

WHEREAS, notice of public hearing was duly advertised in the Lowville Journal and Republican, official newspaper of the Town of New Bremen on November 1, 2023, and

WHEREAS, said public hearing was duly held on November 13, 2023 at 6:30 p.m. at the Town of New Bremen Municipal Building at 8420 State Route 812, Lowville, New York 13367 and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS, pursuant to part 617 of the implementing regulations pertaining to article 8 State Environmental Quality Review Act (SEQRA) it has been determined by the Town Board of the Town of New Bremen that adoption of said proposed Local Law would not have a significant effect upon the environment and could be processed by other applicable governmental agencies without further regard to SEQRA, and

WHEREAS, the Lewis County Department of Planning recommended approval of the proposed Local Law, with suggested modifications, on November 16, 2023, pursuant to section 239-m of the General Municipal Law, and

WHEREAS, the Town Board of the Town of New Bremen, after due deliberation, finds it in the best interest of said Town of New Bremen to adopt said Local Law.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of New Bremen hereby adopts said Local Law No. 1 of the year 2023 to be known as the Town of New Bremen Zoning Law, a copy of which is attached hereto and made a part of this resolution, and be it further

RESOLVED, that the Town Clerk be and is hereby directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of New Bremen and to give due notice of the adoption of said Local Law to the Secretary of State of the State of New York.

COUNCIL REPORTS

Councilwoman Buell reported on the following with resolution to follow:

- ZBA Tim Lee, ZBA member is interested in moving to the towns planning board when it becomes feasible and Jonathan Roes is interested in serving on the ZBA and would fill Mr. Lee's term if approved by the board. Mr. Roes expressed his interest to the board. Mr. Lee will need to submit his letter of resignation. She will be contacting the other interested planning board members to confirm their interest in serving, then reactivation of the planning board can be done by the town board.
- NBCIA2 Received the certificate of its incorporation and noted the new 501c3 will be known as "ReNew Bremen Inc.". Reached out to Attorney Farley concerning the legal fees incurred for its establishment, and whether the town board can expend budgeted funds that were slated for the NBCIA to cover those fees. No response as of yet.
- County-wide Complete Streets Plan County is asking for support for the NYS DOT Carbon Reduction Program (CRP) Grant Application they will be submitting. Councilwoman Buell reviewed the plan which includes an area in the Hamlet of Beaver Falls for a sidewalk. Engineering is underway, but plans are not complete as of yet. Letters of support are due by January 6th.

Councilman Aucter reported on the following:

- Draft RFP for a new roof on the municipal building submitted to the board for their review.
- Assessor Smith he was unable to attend tonight's meeting, but plans to attend the January meeting.

Councilwoman Lyndaker reported on the following:

- Class C Stream Bill was vetoed. Good news for the town.
- Upcoming training at 3G Fire Hall in March to assist towns with the permitting process for culvert replacements.

Highway Superintendent Herzig reported on the following:

- Equipment replacement plan Supervisor Keys asked that he work on.
- CHIPS reimbursement funds have been received.

JUSTICE

Clerk Jones received a letter of resignation from Judge-elect, Samantha DeRycke, she has decided that she will not be able to accept the position of Town Justice. This will leave a vacancy effective 1/1/2024. Supervisor Keys notified Judge Karalunas, as directed by Judge Gideon, Special Counsel to the 5th Judicial District Town and Village Supervising Judges. Judge Gideon also forwarded a copy of section §60-a. Removal of Town Justices from Town Board, from Town Law, which states the town board can adopt a resolution, subject to permissive referendum, to reduce the number of town justices. An ad asking for letters of interest to fill the position was published in the Lowville J & R and on linkinglewiscounty website, with an end date for submission by January 31, 2024. Discussion followed. No action to be taken until after the end of January.
