Supervisor Keys called the meeting to order at 6:00 p.m. with the Pledge to the Flag.

RESOLUTION NO. 1 OF 2016 APPROVAL OF MINUTES

ASSESSOR

Assessor Ball reported on the progress of the reassessment project along with exemptions, property transfers, etc., through his office. After discussion the Board thanked Mr. Ball for attending. He then left the meeting.

COUNCIL REPORTS

Councilman Aucter reviewed the Lewis Co. Search & Rescue "sample" contract and is concerned that it does not guarantee that an ambulance will be retained at the Croghan Fire Department, and that Lewis Co. Search and Rescue could decide to discontinue at any time if they chose. Should this happen, people in our area would then have to wait for an ambulance to come from Lowville. The Board will address this further when it comes time to adopt a contract with them.

HIGHWAY

Clerk Jones submitted a revised County Snow and Ice Control Agreement contract from the County Highway Department for signatures by Supervisor Keys and Superintendent Bush. The County left off the section at the end of the Van Amber Road (bridge to town line). Therefore, they revised the contract per Superintendent Bush's request. Copy of said contract will be incorporated at the end of the December 28, 2015 meeting, when originally approved.

RESOLUTION NO. 4 OF 2016 AGREEMENT FOR THE EXPENDITURE OF HIGHWAY MONEYS

RESOLVED, Pursuant to the provisions of Section 284 of the Highway Law we agree that moneys levied and collected in the Town for the repair and improvement of highways, shall be expended as follows:

General Repairs. The sum of \$426,000.00 shall be set aside to be expended for primary work and general repairs upon 64.65 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.

RESOLUTION NO. 8 OF 2016 DELEGATION OF AUTHORITY - GAMES OF CHANCE

WHEREAS, the Town of New Bremen pursuant to Part 5600 of the rules and regulations of Games of Chance, must appoint a Licensing Officer and Chief Law Enforcement Officer for Games of Chance, therefore be it,

RESOLVED, that Elizabeth B. Jones, Town Clerk is hereby appointed Licensing Officer to review applications, findings, determinations and supplemental papers in regard to issuing licenses, collecting and transmitting fees. Chief Law Enforcement Officer, Michael Carpinelli, Sheriff of Lewis County, will investigate complaints, conduct hearings and supervise the operation of Games of Chance. Appointments effective January 11, 2016 thru December 31, 2016.

RESOLTUION NO. 9 OF 2016 SPECIAL DISTRICTS AND SERVICES

CEMETERY

Supervisor Keys stated the grant funds from the NYS Cemetery Division for the purchase of fencing for the New Bremen Rural Cemetery, were received on November 25, 2015 in the amount of \$5,827.32. Councilman Brooks stated the fencing was ordered through Lowe's, but due to the weather installation will be delayed until weather permits. The fencing has been paid for and materials are being stored by the Highway Department until installation.

FEMA

Supervisor Keys stated that funds from NYS Division of Homeland Security and Emergency Services for the December 22, 2014 Winter Snow Storm of Buffalo, have been received - \$3,072.57 and have been transferred to the Equipment Reserve Fund as set forth in Resolution No. 151 of 2015.
