# REGULAR MEETING July 11, 2022



The Regular Meeting of the Town Board of the Town of New Bremen, County of Lewis and the State of New York was held at the Town Municipal Office Building, 8420 State Rte. 812, New Bremen, New York on the 11<sup>th</sup> day of July 2022.

Supervisor Keys called the meeting to order at 6:30 p.m. with the Pledge to the Flag.

## RESOLUTION NO. 63 OF 2022 APPROVAL OF MINUTES

On a motion of Councilwoman Lyndaker, seconded by Councilman Aucter, the following resolution was ADOPTED Ayes 5 Aucter, Buell, Lyndaker, Schantz, Keys Nays 0

RESOLVED, the minutes of the June 13, 2022 meeting are approved.

## **FLOOR**

Supervisor Keys opened the floor to Laurie Halladay, Curator for the Railway Historical Society. Mrs. Halladay gave a presentation to the Board briefing on the history of the short line railroad from Croghan to Lowville along with work they are doing to preserve several "working" engines providing rides from the Village of Croghan Depot to State Rte. 126 and back. They are also progressing forward with the operation of a trolley car and rail bikes; and need the full Lowville/Beaver River Railroad for said development. Looking for the Town Boards support to continue to move forward with their plans and also noted that the tracks have been deemed historical and donations are welcomed as they are a non for profit organization.

Ron Trottier, owner of Railstar Corp. and President of the Railway Historical Society also presented a brief history of the railroad. Currently working to obtain liability insurance for their rail bikes, which were purchased back in 2016 to help promote rail tourism in the area. They are very popular for ages 6 to 86 and hope to have them operational by the end of July/August of this year and will run from the Village of Croghan Depot to State Rte. 126. He stated that GVT is the owner of the rails and has been working with them. Repairs are needed to the base of the track in several areas, along with trimming of trees and clearing of debris from the tracks. The County of Lewis is supposed to be putting back the 300' of track they ripped up with no knowledge to the company. A July 30th chicken bbq is planned to help raise funds. They will be having train rides and the museum will be opened for people to walk through also.

Mrs. Halladay and Mr. Trottier thanked the Board for their time and left the meeting at 6:55 p.m. Discussion followed with residents that own property along the railroad and are against the County's Rails to Trails project.

- 1. Joanne Dicob, 7714 State Rte. 812 spoke stating "we are not interested in rails to trails" and is opposed to the County's proposed project, which would convert the railroad to public accessed trails for walking, biking, ATV's, snowmobiles, etc., if the county's filing for eminent domain on the railway is a success. There are many residents opposed to the proposed project, as they obtained approximately 400 signatures within 6 days. Said petition was submitted to the County Board of Legislators. Mrs. Dicob is asking for the Boards support in fighting the County and tell them we are not interested in "rails to trails".
- 2. Chad Pate, 10075 Resha Rd. also owns property along the tracks, asking if there is an option for adjacent land owners to the tracks to be able to purchase the property back.
- 3. Jim Kieffer, 8426 Mattis Rd. stated it will open up liability issues for the landowners that use their own land for hunting.

Councilman Aucter would like to see the Board take action now rather than later. Councilwoman Buell feels the County has no idea what the track will be used for, although southern Lewis county could benefit from it. After discussion, Supervisor Keys thanked them all for attending.

- 1. ZBA will be meeting with the new ZBA on July 25<sup>th</sup> at 6 p.m. to discuss the 4 hrs. of training they will need to complete and to assist them setting up a chairman, secretary, when to meet, etc.
- 2. Planning Board still working on, but have several interested people in serving.
- 3. Playground supplies ordered via the grant should be shipping July 27<sup>th</sup>. Brenda Buell is creating a fairy garden along the walking trails in the park.
- 4. Restore NY Grant trying to get the old cheese plant in the sights of the county to clean up the site, with the possibility of the Town assisting. Said project is a priority of hers. There is a 10% match required for this grant.

## Councilwoman Lyndaker

1. NBCIA – with the passing of her Grandmother, Linda Hall, her family would like to donate to the New Bremen Community Improvement Association, but are uncomfortable with the current status of the organization as they have not been filing reports with the Town or State and have not followed through with youth recreation contracts with the Town in a couple years now. Councilman Aucter suggested the family establish a grant as we have contacted our Town Attorney on said matter, but Mr. Farley stated our hands are tied so to speak. Would like some kind of correspondence with Robin Houppert, President of the association. The Board has been unsuccessful.

RESOLVED, that the Town Board of the Town of New Bremen does hereby enter into a contract with the Village of Croghan to provide structured educational activities for the youth of the Town of New Bremen for the 2022 Summer Youth Recreation Program, and that the said Town of New Bremen will expend to the Village of Croghan the sum of \$4,500.00. - 4. ARPA Maintenance Plan continuing to work on the plan.
