CANNABIS

Attorney Farley – the Board needs to decide if it is going to opt out of both cannabis retail dispensaries and on-site cannabis consumption before he can draft the opt out local law. The opt out local law needs to be adopted by December 31, 2021 and is subject to a permissive referendum (or referendum on petition) following the procedure outlined in Municipal Home Rule Law § 24. Meaning if the Town adopts said local law opting out, and there is a petition with a sufficient number of qualifying signatures, then the Town would have to put the local law to a vote. Discussion followed with mixed feelings amongst the Board. After discussion, the following motion was made.

On a Motion made by Supervisor Keys, seconded by Councilman Aucter, to move forward with the drafting of a proposed local law to opt out of both cannabis retail dispensaries and on-site cannabis consumption within the Town's jurisdiction (Cannabis Law §131).
