Supervisor Keys called the meeting to order at 6:00 p.m. with the Pledge to the Flag.

RESOLUTION NO. 25 OF 2015 APPROVAL OF MINUTES

RESOLVED, the minutes of the February 9, 2015 meeting are approved.

DCO

Clerk Jones received a phone call from Todd Phelan, DCO on March 6, 2015. Mr. Phelan stated due to health reasons he planned to hand in his resignation on March 9, 2015. Clerk Jones did not receive it. Supervisor Keys contacted Justin Hall, who is the DCO for 10 other neighboring towns, to see if he was interested. Mr. Hall attended the meeting and expressed his interest in serving as DCO. He has received the pre-exposure rabies shots, has equipment, signs for his vehicle etc. After discussing, the following resolution was presented.

RESOLVED, that Justin R. Hall is hereby appointed as DCO effective March 10, 2015 through December 31, 2015.

COUNCIL REPORTS

Councilman Aucter stated the public informational meeting with Assessor Ball will be held on March 26, 2015 at 6 p.m. at the Town Municipal Office Building. There will be an article in the Journal & Republican as well as on social media, notifying the public and asking that they pre-register.

Councilman Brooks is looking in to grant monies for the New Bremen Rural Cemetery. Councilwoman Sauer contacted the Lewis County Historical Society and they have a list of people buried there along with pictures of grave stones. They are willing to copy the files to a usb drive for the Town.

Councilman Brooks feels it is important to back up the Towns files. The Clerk and Tax Collector files are currently backed up on the computer and on an usb drive, but Councilman Brooks would like to see them backed up off site. Clerk Jones contacted Business Automation Services for a quote. The cost would be \$14.50 per month to backup up to 10 GB of data online. There is a one-time fee to setup, configure and train of \$95.00. The Supervisor's files are backed up by the accountants, on a usb drive and on his computer. The Court backs up on a usb drive and with the software vendor. After discussion, the following resolution was presented.

Supervisor Keys spoke with the Highway Employees and presented several changes they would like to see to the Employment and Liability Guidelines. It was suggested to have a committee to review and make suggested changes to the Employment and Liability Guidelines, as in the past. Councilwoman Sauer, Councilman Brooks and a representative from the Highway Department will set a date to do so.

BE IT FURTHER RESOLVED, that all bids for bank run gravel be accepted and that the Highway Superintendent is authorized to draw from the closest available pit as needed.

HIGHWAY SUPERINTENDENT

Superintendent Bush is working with the DEC to close and reclaim the section of the Lyndaker gravel pit that the town does not own, located on the Wagner Road. The material isn't very good and he feels it doesn't pay to purchase the property or keep it open.

2016 TANDEM

Supervisor Keys stated financing for the 2016 tandem has been approved through First Niagara Leasing, Inc. There will be more information to follow once the truck is closer to being completed.

GOVERNMENT EFFICIENCY PLAN

Supervisor Keys and Councilman Brooks attended a meeting at the county pertaining to the development of a "Government Efficiency Plan". The Town has to join the County or have our own plan. Supervisor Keys explained some of the aspects of the plan. The deadline is March 18th and Supervisor Keys feels it will be easier to join in with the County. The Board has several concerns. Supervisor Keys will write a letter agreeing to join the county with the option of withdrawal from this group plan at any time if in the best interest of the Town. Councilman Brooks has agreed to be the Town's representative. After discussion, the following resolution was presented.
