The Regular Meeting of the Town Board of the Town of New Bremen, County of Lewis and the State of New York was held at the Town Municipal Office Building, 8420 State Rte. 812, New Bremen, New York on the 14<sup>th</sup> day of March 2016.

Deputy Supervisor Aucter called the meeting to order at 6:02 p.m. with the Pledge to the Flag.

**RESOLUTION NO. 23 OF 2016  
APPROVAL OF MINUTES**

On a motion of Councilman Aucter, seconded by Councilman Bush, the following resolution was  
ADOPTED Ayes 3 Aucter, Brooks, Bush Nays 0

RESOLVED, the minutes of the February 8, 2016 meeting are approved.

**PRIVILEGE OF FLOOR**

Deputy Supervisor Aucter opened the floor for comment. Stanley Jantzi, 6974 Kirschnerville Road, Town of New Bremen, submitted a request for variance form, resident approval of variance letter, along with a letter of referral from Ward Dailey, Zoning Officer. Mr. Jantzi would like to install a 14 x 60 manufactured home on a lot located at 7007 William Street. Due to the size of the lot and the size of the mobile home he lacks set back by 11.5 feet. Section 510 (A) of the Towns Mobile Home Law #1 of 1996 – requires a 25' side set back. After discussion/review, the following resolution was presented.

RESOLVED, that a public hearing will be held on April 11, 2016 at 6:00 p.m. at the Town Municipal Office Building to consider the request for variance submitted by Stanley Jantzi, 6974 Kirschnerville Road, New Bremen, New York, for the installation of a manufactured home with a setback of 18' from the property line, to be located on property located at 7007 William Street, Tax Map No. 130.03-01-16.000. **RESOLUTION NO. 27 OF 2016  
BANK RUN GRAVEL BIDS**

BE IT FURTHER RESOLVED, that all bids for bank run gravel are accepted per Highway Superintendent Bush's approval and that the Highway Superintendent is authorized to draw from the closest available pit as needed.

**HIGHWAY SUPERINTENDENT**

Superintendent Bush asked the Board for permission to advertise for bid for sale old surplus parts that are obsolete and no longer needed that have accumulated over the years. He would like to advertise on the Auctions International website. After discussion, the following resolution was presented.

**RESOLUTION NO. 28 OF 2016  
PERMISSION TO ADVERTISE FOR BID FOR SALE**

On a motion of Councilman Aucter, seconded by Councilman Brooks following resolution was  
ADOPTED Ayes 3 Aucter, Brooks, Bush Nays 0

RESOLVED, that Highway Superintendent Bush has permission to advertise for bid for sale "old surplus parts that are obsolete and no longer needed", on the Auctions International Website, with the Board reserving the right to reject any or all bids.

Superintendent Bush gave a brief report on the Highway Superintendent's Advocacy Day in Albany he attended. Also, presented a resolution to the Board for their review/consideration pertaining to "Local Transportation Funding". After discussion, the following resolution was presented.

**RESOLUTION NO. 29 OF 2016  
LOCAL TRANSPORTATION FUNDING**

On a motion of Councilman Brooks, seconded by Councilman Aucter following resolution was  
ADOPTED Ayes 3 Aucter, Brooks, Bush Nays 0

WHEREAS, a reliable transportation infrastructure is vital for the safety of New York's travelling public and its economy; and

WHEREAS, 85 percent of New York's roads and bridges are maintained by local governments; and

WHEREAS, despite well-timed and targeted preventative maintenance treatments, the age and condition of many of our locally-owned transportation assets means that they are beyond preservation and in need of much more costly rehabilitation and reconstruction; and

WHEREAS, estimates by the State Comptroller, DOT and independent studies show a large number of road mileage is deteriorating and many bridges in the state are rated structurally deficient and functionally obsolete; and

WHEREAS, the State Comptroller estimates that there will be \$89 billion in unmet local infrastructure needs over the next 20 years; and

WHEREAS, the New York State Association of Town Superintendents of Highways commissioned its own fifteen year analysis that indicates an annual funding gap of \$1.3 billion for the local system (excluding NYC) alone; and

WHEREAS, funding for our local system has been far short of what is needed and we've fallen further and further behind in maintaining the vast and aging transportation infrastructure over this long period with severe consequences for conditions ratings; and

WHEREAS, the New York State Consolidated Local Street and Highway Program (CHIPS) provides essential funding for every municipality in the state and is part of the New York State Department of Transportation (NYSDOT) Capital Program; and

WHEREAS, we urge the Governor and Legislature to make additional state funding and resources available at levels that accurately reflect the critical needs of local roads and bridges; and

WHEREAS, in the early 1990's the Governor and Legislature created the Dedicated Highway and Bridge Trust Fund (DHBTF) to pay for the NYSDOT capital program and the Dedicated Mass Transit Trust Fund (DMTTF) to assist with the Metropolitan Transportation Authority (MTA) and other transit systems' capital programs; and

WHEREAS, when created it was agreed that the NYSDOT and MTA five-year capital programs would be similar in size and would be negotiated concurrently; and

WHEREAS, through 2005-09, both five-year capital programs were similar in size and adopted within months of each other; and

WHEREAS, in 2010 the Executive and Legislature broke traditional parity and enacted a five-year capital program for the MTA but not the DOT; NOW THEREFORE BE IT

RESOLVED, that the Town of New Bremen calls upon the Governor and the state Legislature to increase CHIPS funding in the 2016-17 state budget; and BE IT FURTHER

RESOLVED, that the Town of New Bremen calls upon the Governor and members of the state Legislature to fully fund and submit a new NYSDOT five-year transportation capital plan; and BE IT FURTHER

RESOLVED, that the Town of New Bremen calls upon the Governor and members of the state Legislature to recognize the equality of roads, bridges and transit by restoring funding equality between the MTA and NYSDOT five-year programs and by voting on the plans simultaneously.

**SNOW BELT HOUSING**

Cheryl Shenle-O'Neill, Ex. Director of Snow Belt Housing sent a letter of request for the Boards support in Snow Belt Housing's application to the Development Authority of the North Country, for funds to continue its successful owner-occupied rehabilitation program which would benefit low and moderate income residents of the Town of New Bremen. After discussion, the following resolution was presented.

WHEREAS, the Town Board of the Town of New Bremen supports Snow Belt Housing's application to the Development Authority of the North Country for funds to continue its successful owner-occupied rehabilitation program to benefit our Town, now, therefore be it

RESOLVED, that the Town Board of the Town of New Bremen authorizes Snow Belt Housing Company, Inc. to submit an application on behalf of the Town of New Bremen for grant funding through the Development Authority of the North Country.

**ZONING**

The Board will review the information on both the Halko and Cady properties and discuss further action at the next regular board meeting after conferring with Attorney Farley.

**NBCIA**

Robin Houppert, 9188 Deveines Road has taken over as President of the New Bremen Community Improvement Association (NBCIA). She will be responsible for the scheduling of the New Bremen Ball Field, the accounts payable and accounts receivable for the Association. The Board would like more information on

the other Board members. Councilman Aucter will contact Mrs. Houppert and report back to the Board at the next meeting.

## **YOUTH BUREAU**

Deputy Supervisor Aucter reported the Town does “not” qualify for the grant funding for summer youth recreation through the Lewis County Youth Bureau because they are “not” Town run programs.

## **SEARCH & RESCUE**

Justin Astafan, Chief of Operations for the Lewis County Search and Rescue, Inc., sent a letter in reference to the Croghan Ambulance and Lewis County Search and Rescue talks regarding EMS coverage for Croghan’s area and the merging of services effective April 3<sup>rd</sup> with the Lewis County Search and Rescue and Croghan Ambulance. They have received a county wide Certificate of need to operate and be able to bill for calls outside of their current authority which will allow them to operate in Croghan Ambulance’s area. To help offset the costs and help provide the best service possible they are requesting a contract with the Town. They calculate the contract price by population in the response area. They are requesting a rate of \$5 a resident which would equate to \$5,835 for 2016, but due to the time starting they deducted the first quarter. The total contract for 2016 is \$4,376.25. They submitted a contract for the Boards consideration after a public hearing is held by the Town Board. After discussion, the following resolution was presented and request that representatives from the S &R attend along with someone from the Croghan ambulance also.
