REGULAR MEETING October 11, 2021

Supervisor Keys called the meeting to order at 6:30 p.m. with the Pledge to the Flag.

RESOLUTION NO. 89 OF 2021 APPROVAL OF MINUTES

On a motion of Councilman Becker, seconded by Councilwoman Lyndaker, the following resolution was ADOPTED Ayes 5 Becker, Aucter, Buell, Lyndaker, Keys Nays 0

RESOLVED, the minutes of the September 13th and October 4th, 2021 meetings are approved.

COUNCIL REPORTS

Councilman Aucter

1. ARPA funds – suggested posting a notice on the towns website and to the media, stating those interested in receiving ARPA funding, should send a letter of request to the Town Board. Discussion on spending of funds followed.

Councilwoman Lyndaker

- 1. Tug Hill Commission is hosting a webinar on October 19th from 12 to 1 pm about the American Rescue Plan Act. Contacted other towns to see what they are spending their ARPA funds on. No one really yet.
- 2. Chamber of Commerce Spoke with Kristin Aucter concerning community mural (billboard). If interested we need a building or spot for it, ideas for a design and apply by November 5th.

Councilwoman Buell

- 1. Lewis County Chamber of Commerce acquired four (4) murals created by artist ARCY at this year's Lewis Co. Fair. They are looking for community playgrounds within the county to display them and they chose our very own Ralph "Bub" Hall Memorial Playground. Highway Superintendent Herzig and I agreed on its placement and the highway crew will install it this week.
- 2. RACOG Spoke with Mickey Detriech from the Tug Hill Commission/RACOG about joining RACOG. They have many local government resources available for members Cooperative ZBA, access to Tug Hill Commission and their resources, website, etc. Would be able to participate in the ZBA as a Lewis County municipality with Jefferson County municipalities, which would require us finding one (1) member for the ZBA. Cost is \$450 yearly or \$650 with ZBA cooperative.

COUNTY

Ian Gilbert, Legislator for District No. 4 reported on the following:

- 1. Toured the old cheese plant Their goal is to clean up the property and sell to a private buyer. Mostly non-toxic items on-site accept for asbestos, which they put out RFP's on.
- 2. County budget working towards a 0% increase for 2022.

HIGHWAY SUPERINTENDENT

Highway Superintendent Herzig reported on the following:

- 1. OSHA Violations Mr. Herzig submitted and reviewed with the Board a list of violations we were cited for. Awaiting to receive the "notification of violation" letter before some items can be addressed; with several of the issues being completed already. Largest is the fuel tank storage building removal.
- 2. Jacob Fetterman of Trout Unlimited They are working on improving road stream crossings, to benefit aquatic organism passage and would make the crossings more resilient to high water and flooding. They are looking at a trout stream on the Brewery Road and would consist of replacing the current culvert with a 13' wide, open-bottom cement cast culvert at no cost to the Town and they perform the work.
- 3. Bridge NY still waiting to hear if we were awarded a grant for the projects submitted.
- 4. Crosswalk Discussion Board feels it is more of a school issue and if the school feels the need for a crosswalk they need to request the Towns support in the matter.
- 5. Mowing Tractor Submitted 2 quotes for the Board's review for the purchase of a new mowing tractor with attachments. New Holland through Tracey Road Equipment and John Deere through Stephenson Equipment, Inc. Prices are expected to increase after the 1st of January. No action taken, will continue to review and get resale or trade in value of our 2008 New Holland tractor. Board is not interested in using CHIPS funding to offset the cost of a new tractor due to the 10-year requirement.
- 6. Sale of tandem Discussed whether to advertise it for sale on Auctions International or advertise for bid ourselves. No action taken.

REAL PROPERTY TAX EXEMPTIONS

Reviewed the current real property tax exemptions. Assessor Ball recommended they remain the same for 2022. After discussion, the following resolution was presented.

TRANSFER OF FUNDS

Supervisor Keys presented a transfer of \$30,000.00 from A9902.9 to the equipment reserve and/or building reserve funds. After discussion, the following resolution was presented.

RESOLUTION NO. 94 OF 2021 TRANSFER OF FUNDS

On a motion of Councilman Aucter, seconded by Councilman Becker, the following resolution was ADOPTED Ayes 5 Becker, Aucter, Buell, Lyndaker, Keys Nays 0

RESOLVED, that Supervisor Keys is authorized to transfer \$10,000.00 from A9902.9 to the Equipment Reserve Fund and \$20,000.00 from A9902.9 to the Building Reserve Fund.

INSURANCE

Supervisor Keys, Clerk Jones and a couple highway employees met with Robert Ransier, Brown & Brown insurance agents to review 2022 health and dental insurance packages and premiums as an 8.9% premium increase is projected for 2022. Discussed lowering the employee's contribution rate from the current 30% to 25% for 2022, as the HRA plan has been excellent for the Town along with the employee participating in the insurance. The Board is in favor, but would like Supervisor Keys to be sure the amounts in the 2022 preliminary budget for insurance will be sufficient to cover the Towns share. Will review further at the November regular meeting.

EMPLOYMENT AND LIABILITY GUIDELINES

Discussed updating the guidelines to allow or give the option when hiring that the candidate may reside out of the township and/or left to the discretion of the highway superintendent when hiring. No action taken.
