REGULAR MEETING October 9, 2023



The Regular Meeting of the Town Board of the Town of New Bremen, County of Lewis and the State of New York was held at the Town Municipal Office Building, 8420 State Rte. 812, New Bremen, New York on the 9th day of October 2023.

Deputy Supervisor Aucter called the meeting to order at 6:34 p.m. with the Pledge to the Flag.

RESOLUTION NO. 80 OF 2023 APPROVAL OF MINUTES

RESOLVED, the minutes of the September 11, 2023 meeting are approved.

OPENING OF FLOOR - SOLAR

Ashley Harkness with Kimley-Horn Civil Engineering Consulting Firm, representing their client CVE North America, the solar developer and applicant for a 5MW solar project to be located at 8048 Hopps Road, Town of New Bremen. Ms. Harkness came to brief on the proposed project and gain an understanding of what is required by the town. The project is in beginning stages and looks to be December before they would have a site plan application submitted for the board's review and consideration. Discussion followed. Councilwoman Buell made mention that the board is currently in the process of updating the towns zoning law which could possibly have an impact on the proposed project. The board addressed Ms. Harkness' questions and concerns. She thanked the board for their time and left the meeting at 7 p.m.

GREEN WASTE

Tom Kalamas – Town of Croghan submitted a "green waste policy" for the boards review/discussion. They are hoping with this policy in place that it will put a handle on dumping of large stumps and logs at the site, as it has become a problem and a great expense to the towns. Would like the boards input on any changes to the policy for their November meeting. Their objective is to approve said policy then. Councilwoman Buell suggested the possibility of a shared services program between the county and towns to purchase a wood chipper instead of hiring out the work. She will research further. Mr. Kalamas and Mr. Jones left the meeting at 7:08 p.m.

- Co. Shared Services Plan county is still looking for ideas for "new" shared services programs from towns.
- Speed Radar Signs waiting to hear back from TAPCO on final pricing and information pertaining to the cloud storage after the first free year, then hoping to discuss further with HS Herzig and place the order.
